PREPARATION

All participating countries will have to provide a presentation regarding Human Rights in their countries. The presentation has to be prepared from each team's participants and shall be presented in a 15-minute session on one of the days of the project.

Educational Organization Sharp Minds will provide you with a ready template as well as the categories, so to focus on specifics in your research.





KEEP IN MIND

Educational Organization Sharp Minds provides the space for new ideas to flourish. Leaders from each country and young people themselves will be developing the program and executing all the activities.

We highly encourage a polite, participatory attitude, therefore all participants are required to have the willingness to explore and learn. This is an educational project, with various methods of learning.

Additionally, we will try to limit our meat and dairy consumption due to European Guidelines for combating the climate crisis.

PARTICIPANTS

The project accepts participants from 18-40 years old. At least 80% of each participating team has to provide participants under 30 years old.

All participants are required to have a valid European certificate of vaccination or a valid certificate of recovery from covid-19, due to regulations provided by the Greek government. All certificates have to be valid till the end of the project (6th of April). **We strongly recommend that participants should have complete vaccination including boost dose.**

It is strongly advised for participants to have good knowledge of English, due to the terminology sessions that will be provided throughout the project.



ACCOMMODATION

Educational Organization Sharp Minds has booked Iconic Athens Hostel for the accommodation of both APV and Training Course. During the Training Course, the hostel will be fully booked for the project. A metro line is within 1-minute walking distance from the hostel and the building is located in a central, safe region of Athens.

Both trainings and meals will be hosted in the hostel. There will be a team of chefs hired by E.O. SHARP MINDS, therefore dietary restrictions will be handled internally.





TRAVEL EXPENSES

Educational Organization Sharp Minds will directly buy all tickets for the project. Further expenses (train, metro) for the training will be reimbursed after the end of the project. All participants should provide the tickets or receipts for the reimbursement. The reimbursement will be sent to each organization's bank account, after gathering all return tickets.

All participating teams are required to provide details regarding their transfer for the arrangement of the flights. All participants are required to participate in the project and no changes will be accepted.



INSURANCE

All participants are obliged to have a valid **European Health insurance card**. For out-of-EU countries, participants are advised to have a private health insurance plan.

Educational Organization Sharp Minds will provide the participants with **two covid-19 rapid tests** during the Training Course. Additional tests for your return (in case they are required by regulations) are covered by the participants. E.O. Sharp Minds will provide you with a clinic and a lower price rate for your obligatory return tests.
